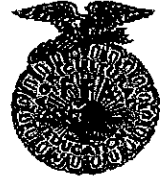

- D. Do not place application in any type of binder or cover.
- E. Application must be postmarked by April 15th to : Rita Balichek, Olin School District, 212 Trilby Street, PO Box 320, Olin, Iowa 52320.
- F. Scholarships will be paid after successful completion of the first semester and upon receipt of second semester registration. It is the recipients responsibility to send confirmation of the second semester registration along with your student ID number to the Olin School in order for the scholarship payment to be made. Scholarship money will be mailed to the Office of the Registrar of the applicants college.
- G. There will be a maximum of \$1,000.00 available for this scholarship each year. The scholarship committee will decide how many at what amount each year.

ELIGIBILITY REQUIREMENTS:

- A. The applicant must currently live within the Olin School District boundary's.
- B. The applicant must be a senior in high school and have maintained a satisfactory scholastic record in school.
- C. The applicant must major in a program offered through an accredited university or technical college with special consideration given to student with interest in agriculture.
- D. The applicant must currently be attending the Anamosa or Midland Community School and must be "Whole Grade Shared" status.
